School Facility Conditions and Planned Improvements

Our site houses students from transitional kindergarten to eighth grade. We have ten modular classrooms, including a STEAM/Maker lab. Additionally, we have a TK room, multipurpose room, resource/speech room, intervention room, kitchen, and four offices for the after-school coordinator, attendance, business manager, and director.

Our students enjoy playing on our play structure, swings, blacktop, two basketball courts, and field.

The general condition of our school meets the Good rating on the Facilities Inspection Tool, which was updated in August.

We utilize a facility maintenance plan that sets aside funds each year to accommodate long-term facility repairs and upgrades. We continue replacing HVAC units in two more classrooms and will continue replacing units each year until all classrooms have updated ventilation systems. We plan to expand our facilities to provide increased learning spaces. We purchased land to build a gym and are in the planning phase of development.

We do not receive deferred maintenance funding from the state at this time.
